Introduction

I hope you will find here the necessary keys to current events and debates. Many of these issues (guns, the death penalty, the character of George W. Bush) are controversial, or at least trigger personal reactions. You must not be afraid of asserting your enthusiasm or disagreement with these topics and with the way America views them. On the contrary, a shy candidate, with a dull presentation of the topic is uninteresting for the jury. If you are questioned about such a « hot » debate, you must bring in the controversy, and your opinion. My advice is that 1. you conjure up both sides of the debate, with specific references, and, 2. ultimately you take position. I will not personally comment and discuss these events, it is your job to develop your own opinion about it, and the arguments (in English) that you'd like to put forward if asked about them. My point here is to provide the vocabulary and the historical and political background that will be expected from you. You must clearly understand what is expected from you : any opinion is respectable, you cannot be judged and penalized upon your opinion, but if you do not inform your presentation and position with examples and references, you will not be convincing, and therefore will have failed the requirements of the essay or the oral examination.

I. America's institutional quandaries

1. The First Amendment: The separation of Church and State

You read last month about the American Constitution, I will refer to it in several *occurrences*¹ and I strongly recommend that you should² do the same: this will be one of the assets³ of your (oral or written) presentation, if you are able to quote specific references that allow to *grasp*⁴ the debate better –again, I too often hear candidates judging Americans without suggesting first what might be the cause of such and such feature of American life. Only once you have reminded the hard facts and objective references, can you⁵ propose your critical opinion.

The **First Amendment** to the American Constitution guarantees freedom of religion⁶, as a consequence of the **Separation of Church and State**. According to this principle, and contrary to a Monarchy (and especially contrary to Great-Britain), no religious references can be involved in the political life. I hope you are already bothered by my statement for there are so many *infringements*⁷ to this rule in the American public life, that you are *bound* to⁸ think of at least one occasion when this principle is certainly not respected.
